### TOURNAMENT REGULATION

#### ART.1 ORGANIZATION

THE COMPANY A.S.D. ORGANIZE AN INTERNATIONAL TOURNAMENT DENOMINATED: MARCO AURELIO CUP IN COLLABORATION WITH: L.N.D. - CR LAZIO WHICH WILL BE DISPUEED IN THE DAYS 26-27-28-29 JUNE AT THE SPORTS PLANT: "TOTTI SPORTING CLUB" .

**ART:2 CATEGORY OF PARTICIPATION AND AGE LIMITS** THE TOURNAMENT IS RESERVED TO FOOTBALLERS BELONGING TO THE 8TH FOOTBALL CATEGORY WHICH HAVE COMPLETED THE 15TH YEAR OF AGE. THE FIGC MEMBERS ARE ALLOWED FOR THE SOCCER COMPANIES IN THE DILECTING SECTOR, THE UNCESSIVENESS FIGC FIGURES WHOSE NOMINATIVES SHOULD BE SIGNED TO A.S.D. FOR THE PREVENTIVE CONTROL AT THE CARDS OFFICE.

#### ART.4 PLAYERS LIST

THE PARTICIPATING COMPANIES WILL HAVE TO PRESENT AT THE ORGANIZATION OF THE TOURNAMENT, BEFORE THE HIS START, THE LIST OF SOCCER PLAYERS WHICH INTEND TO USE, UP TO A MAXIMUM OF N ° 20 AFTER THE PRESENTED DELIVERY IT IS PROHIBITED TO MAKE CHANGES TO THESE LISTS. IN THE DISTING TO PRESENT THE REFEREE BEFORE THE RACE WILL BE INDICATED UNTIL A MAXIMUM OF 16 PLAYERS.

#### ART.5 SUBSTITUTIONS

UNLIMITED SUBSTITUTIONS, INDEPENDENTLY OF THE MATCH, WHICH CAN BE MADE AT ANY TIME OF THE MATCH ARE PERMITTED.

#### ART.6 PARTECIPATING COMPANIES

#### ART.7 TOURNAMENT FORMULA

THE TOURNAMENT WILL TAKE PLACE WITH THE FOLLOWING FORMULA AND METHOD OF QUALIFICATION: 5 ITALIAN ROUNDS WITH TEAMS COMPETING IN ONE-WAY RACES. THE FIRST PLACE OF THE 5 ROUNDS OF EACH ROUND WILL ACCESS DIRECTLY TO THE QUARTER FINALS, THE SECOND PLACE AND THE BEST THIRD PLACE WILL BE ABLE TO CARRY OUT AN ELIMINATORY ROUND FOR THE PREQUARES OF FINAL. THE METHODS WILL BE DETERMINED ACCORDING TO THE CRITERIA ESTABLISHED IN THE FOLLOWING ART. 8 (RANKINGS).THE COMBINATIONS OF THE PHASE WITH DIRECT CLASHES WILL BE DETERMINED AS PER THE ATTACHED TABLE, TAKING

INTO ACCOUNT THE RANKING OF ALL THE FIRST PLACES, THE RANKINGS OF ALL THE SECOND PLACES AND THE THIRD BEST PLACE.

#### **ART.8 STANDINGS**

THE CLASSIFICATIONS WILL BE DRAWN UP ACCORDING TO THE FOLLOWING CRITERIA:

3 POINTS FOR VICTORY –

1 POINT FOR THE DRAW –

0 POINTS FOR DEFEAT IN CASE OF EQUAL SCORE, THE CRITERIA IN ORDER LISTED ARE VALID: 1.

OUTCOME OF DIRECT MEETINGS 2. DIFFERENCE NETWORKS ON THE TOTAL OF THE MEETINGS

DISPUTED IN THE GIRONE 3. MORE NUMBER OF NETWORKS ON THE TOTAL OF THE MEETINGS

DISPUTED IN THE GIRONE 4. DISCIPLINE CLASSIFICATION 5. DRAWING.

IN CASE OF DETERMINING THE RANKING OF ALL THE FIRST PLACES, OF ALL THE SECOND

PLACES AND OF THE THIRD PLACES, THESE WILL BE THE CRITERIA:1. NUMBER OF POINTS

ACHIEVED2. GENERAL NETWORK DIFFERENCE3. MORE NUMBER OF SCORED NETWORKS4.

#### **ART.9 MATCH TIMES**

THE MATCHES WILL BE HELD IN 2 (TWO) TIMES OF THE DURATION OF 25 MINUTES EACH.

8> 8 MATCHES ARE PLAYED ON FIELDS OF REGULAR DIMENSIONS WITH REGULAR DOORS AND USE BALLS N ° 5.

#### **ART.10 PENALTIES** (PROVIDED IN THE FINALS, SEMIFINALS OR GAMES IN DIRECT ELIMINATION)

IN CASE OF EQUAL AT THE END OF THE TWO REGULATORY TIMES, THEY WILL CARRY OUT THE EXECUTION OF PENALTIES WITH THE MODALITIES SET BY THE RULE 14 OF THE GAME RULES AND THE OFFICIAL DECISIONS FIGC.

#### **ART.12 REFEREES**

THE MATCHES WILL BE DIRECTED BY REGISTERED REFEREES.

#### **ART.13 TOURNAMENT COMMITTEE**

A TOURNAMENT COMMITTEE WILL BE PREPARED TO BE RESPONSIBLE FOR ANY DISPUTE, PROTEST, COMPLAINT OR UNFORESEOUS CIRCUMSTANCE. THE COMTATO WILL BE COMPOSED OF THE FOLLOWING PERSONS:

**THE COMMITTEE WILL PROVIDE TO REPORT TO ITS NATIONAL OR INTERNATIONAL FEDERATION, INTENDED TO ADOPT THE OPENED MEASURES TAKEN, EVERY PLAYER AND EVERY MEMBER OF THE PARTICIPATING DELEGATIONS BELIEVED BY THE GUIDELINES OF ANTISPORTIVE CONDUCT DURING THE TOURNAMENT**

#### **ART.14 DISCIPLINE OF THE TOURNAMENT**

THE DISCIPLINE OF THE TOURNAMENT IS ENTRUSTED TO THE SPORTING JUDGE HOLDER OR SUPPLEMENT OF THE COMMITTEE OF COMPETENCE

**ART.15 AUTOMATION OF SANCTIONS**

THE AUTOMATION OF THE SANCTIONS IS PROVIDED WITH THE FOLLOWING METHODS: THE PLAYER EXPANDED DURING A MATCH WILL NOT BE PARTICIPATED IN THE NEXT MATCH SAVED GREATER SANCTIONS INFLICTED BY THE JUDGE SPORTS; THE PLAYER WHO IN THE COURSE OF THE TOURNAMENT ENCOURAGES IN THE SECOND ADMISSION WILL BE DISQUALIFIED FOR A DECLARATORY COMPETITION OF THE SPORTS JUDGE.

**ART.16 COMPLAINTS**

ANY COMPLAINTS MUST BE PRESENTED WITHIN 30 MINUTES FROM THE END OF THE COMPETITION ACCOMPANIED BY THE 100.00 EURO TAX; COPY OF THE COMPLAINT MUST BE DELIVERED TO COUNTERPARTS ALWAYS IN TERMS OF 30 MINUTES.

**ART. 17 INSURANCE**

IT IS RESPONSIBILITY FOR EVERY PARTICIPATING PARTNER TO ENSURE THE INSURANCE COVER TO OWN PLAYERS. THE ORGANIZATION OF THE TOURNAMENT IS RESPONSIBLE FOR THE REGULARITY OF INSURANCE COVERAGE.

**ART.18 WAITING TIME**

CONSIDERING THE TIME RESTRICTED BETWEEN ONE MATCH AND THE OTHER AND CONSIDERING THE INTENSE PROGRAM OF EACH DAY, THE WAITING TIME THAT EACH TEAM MAY TAKE IS LIMITED TO 10 MINUTES (IN REFERENCE TO THE HYPOTHETICAL START TIME OF THE RACE). PENALTY FOR A LONGER DELAY IS THE TABLE DEFEAT. THE ONLY CASE OF JUSTIFIED RACE DELAY IS IN CASE IT IS DUE TO ORGANIZATIONAL REASONS BY THE TOURNAMENT PRESIDENT.

**ART.19 CODICE ETICO**

DURING THE COMPETITION THE FOOTBALLS ARE HELPED TO WEAR THE SAME MESH, THE SAME SHORTS AND THE SAME SOCKS, ALSO ALL THE COMPONENTS (PLAYERS AND STAFF) OF THE COMPANIES PARTICIPATING IN THE TOURNAMENT HAVE THE OBLIGATION TO WEAR WITHIN THE SPORTS CENTERS "DABLIU EUR "AND" THREE FOUNTAINS "THE SOCIAL CLOTHING FOR THE ENTIRE DURATION OF THE EVENT AND MUST MAINTAIN A CORRECT BEHAVIOR AND RESPECT FOR ALL THE PARTICIPANTS, THE OPERATORS AND THE PUBLIC.

**ART.20 GENERAL RULES**

AS NOT FORESEEN BY THIS REGULATION, THE PROVISIONS OF THE FEDERAL REGULATIONS AS COMPATIBLE AND THOSE SHOWN ON THE OFFICIAL COMMUNICATE N ° 1 OF L.N.D. (NATIONAL DAMAGING LEGA).
